### EXECUTIVE OFFICER'S UPDATE

**O**n May 19th, LAFCO staff certified the results of the 2009 Special Districts Commission elections. Installation proceedings will be arranged for district representatives Ingalls and MacKenzie, and city representatives and Mayors Jim Janney and Mark Lewis at the June 1, 2009 LAFCO meeting.

June 1st will be the last day of LAFCO employment for Tita-Jacque Cayetano. Tita-Jacque has been LAFCO's Administrative Assistant for nearly ten years and will join the support staff at the Otay Water District. Tita-Jacque was an instrumental member of the LAFCO staff and will be missed.
