EXECUTIVE OFFICER'S UPDATE

On May 3rd, the San Diego LAFCO adopted jurisdictional conflict resolution and water supply policies. On May 6th, the Rancho Santa Fe Community Services District received final administrative approval from LAFCO to begin undergrounding utilities.

During the summer, Commissioners Andy Vanderlaan & Carl Hilliard, Executive Officer Mike Ott and Consultant Harry Ehrlich attended multiple meetings of the Coalition of California LAFCOs (CCL).

On June 3rd, Chief of Policy Research Shirley Anderson and Mike Ott attended the Annual Fire Chiefs and Burn Institute luncheon.

On July 7th, Mike Ott was appointed by CALAFCO to be the regional chair of an Executive Board Nominating Committee.

In June and July, a number of operational projects were initiated by LAFCO staff: Work began on updating the San Diego LAFCO's website. The

new site will feature higher resolution photos and improved functionality. Chief of Government Services Ingrid Hansen completed a work plan for an electronic document management system. Local Government Analyst Robert Barry received the first set of drawings from an office planner. Office renovation should be underway in 2010-11.
