Notice is hereby given the San Diego Local Agency Formation Commission (“LAFCO”) will hold a regular meeting on **Monday, August 5, 2019** at 9:00 a.m. at the County Administration Center, Room 302, 1600 Pacific Highway, San Diego, California, to consider the following matter:

**“PAUMA VALLEY FIRE REORGANIZATION” |
 DIVESTITURE OF FIRE PROTECTION AND EMERGENCY MEDICAL SERVICE POWERS FOR
 PAUMA MUNICIPAL WATER DISTRICT, YUIMA MUNICIPAL WATER DISTRICT, AND
 MOOTAMAI MUNICIPAL WATER DISTRICT; AND
 CONCURRENT EXPANSION OF COUNTY SERVICE AREA NO. 135 (FIRE/EMS)
 LAFCO FILE NOS. RO18-13 et al.**

The public hearing is for LAFCO to consider a reorganization proposal filed by resolutions of the Pauma Municipal Water District (MWD), Yuima MWD, Mootamai MWD, and the County of San Diego requesting approval for: (1) divestiture of fire protection and emergency medical service powers within the service areas of the three MWDs, totaling approximately 18,565 acres, (2) a concurrent amendment to the sphere of influence for County Service Area (CSA) No. 135’s activated latent fire protection and emergency medical powers area (Fire/EMS) to include the affected territory, and (3) concurrent expansion of CSA No. 135 (Fire/EMS) to include the affected territory. The San Diego County Fire Authority would assume responsibility for fire protection services and related emergency medical services to the affected territory through CSA No. 135 (Fire/EMS) following the reorganization.
