NOTICE OF RESCHEDULED PUBLIC HEARING

Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a virtual public hearing on **Monday, April 5, 2021 at 9:00 a.m.** with Commissioners participating remotely utilizing video and teleconference technologies consistent with the Governor’s Executive Orders for physical distancing due to the COVID-19 pandemic. At the virtual public hearing, LAFCO will consider the following matter:

PROPOSED “RANCHO CORRIDO RV PARK REORGANIZATION”
CONCURRENT ANNEXATIONS TO YUIMA MUNICIPAL WATER DISTRICT,
SAN DIEGO COUNTY WATER AUTHORITY, AND METROPOLITAN WATER DISTRICT OF
SOUTHERN CALIFORNIA WITH CONFORMING SPHERE OF INFLUENCE ACTIONS
LAFCO FILE NO. RO20-21 et.al

San Diego County LAFCO has rescheduled a hearing previously calendared for March 1, 2021 to April 5, 2021 to consider a reorganization proposal filed by the Yuima Municipal Water District (MWD) involving concurrent annexations to Yuima MWD, San Diego County Water Authority, and Metropolitan Water District of Southern California. Conforming sphere of influence amendments for all three subject agencies will also be considered by the Commission. The affected territory includes one unincorporated parcel (130-040-16) totaling 31.29 acres and subject to an existing County of San Diego-approved Major Use Permit for operation of a 120-unit recreational vehicle park. Documents regarding the reorganization proposal item will be available for review on LAFCO’s internet website at www.sdlafco.org no later than 72-hours before the rescheduled hearing. The public is encouraged to review these materials and provide comments before or during the April 5th public hearing. Further, should LAFCO approve the proposed reorganization, protest proceedings shall also be waived unless written opposition is received from any affected landowners or registered voters prior to the close of the hearing. It is also noted there is a potential for the extension and/or continuation of previously authorized charges, fees, assessments, or taxes.
