**FALLBROOK PUBLIC UTILITY DISTRICT, RAINBOW MUNICIPAL WATER DISTRICT, NORTH COUNTY FIRE PROTECTION DISTRICT, AND COUNTY SERVICE AREA NO. 81**

In accordance with Government Code Section 56430, LAFCO will open a public hearing to consider taking formal action to update – with or without amendments – the spheres of influence for the four affected agencies in the Fallbrook Region: Fallbrook Public Utility District; Rainbow Municipal Water District; North County Fire Protection District; and County Service Area No. 81. An associated municipal service review on the Fallbrook region with specific focus on the referenced agencies serves as the source document in informing the updates and is available for viewing online at [www.sdlafco.org](http://www.sdlafco.org). The agenda report on the item with specific recommendations - including an anticipated recommendation to establish a special study area for North County Fire Protection District to include properties located within Riverside County - will be available online by January 24, 2022. The public is encouraged to review these materials and attend the public hearing on Monday, February 7<sup>th</sup>.
