NOTICE OF PUBLIC HEARING

Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, March 6, 2023 at 10:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “BORREGO SPRINGS FIRE PROTECTION DISTRICT REORGANIZATION” -
 DISSOLUTION OF BORREGO SPRINGS FIRE PROTECTION DISTRICT AND CONCURRENT ANNEXATION TO SAN
 DIEGO COUNTY FIRE PROTECTION DISTRICT**

During the public hearing, LAFCO will consider the reorganization proposal filed by resolution of the Borrego Springs Fire Protection District (FPD) involving approximately 194,400 acres of unincorporated territory within Borrego Springs FPD’s jurisdictional boundary. The proposed reorganization involves the dissolution of Borrego Springs FPD and further requests and transfer all assets, liabilities, and related duties its active fire, emergency medical and ambulance functions to San Diego County FPD via annexation. The affected territory – i.e., Borrego Springs FPD’s existing jurisdictional boundary – is approximately 193,400 acres in size with an estimated resident population of 3,105.

Documents regarding the reorganization proposal item – including a map of the proposed affected territory – are available for viewing online at www.sdlafco.org now and will include posting of the staff report and recommendation no later than 96-hours before the scheduled hearing. The public is encouraged to review these materials, provide comments, and attend the public hearing on Monday, March 6th. Additional details on public participation and submittal of comments are also available at the LAFCO website. Importantly, should LAFCO approve the proposal, a subsequent protest hearing for all landowners and registered voters within the affected territory will be separately noticed.

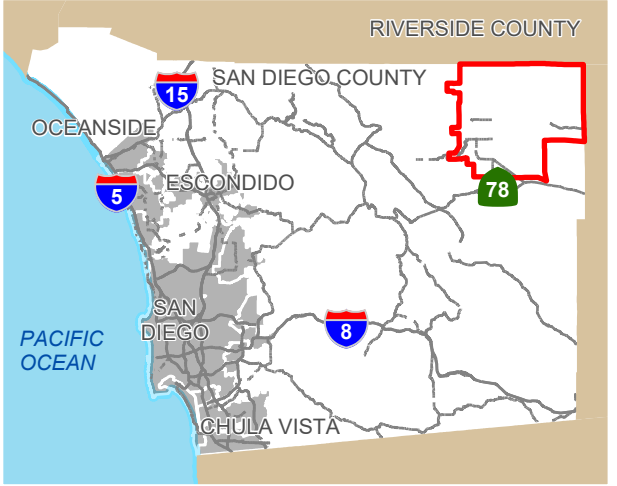
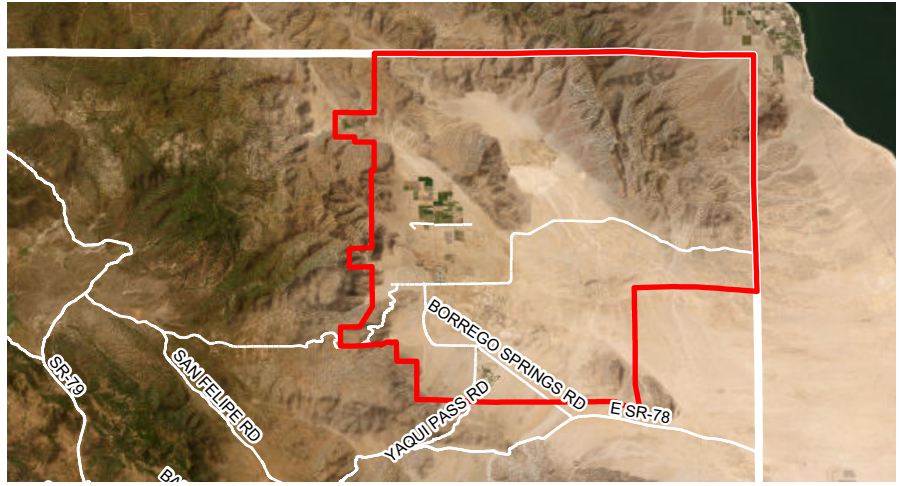
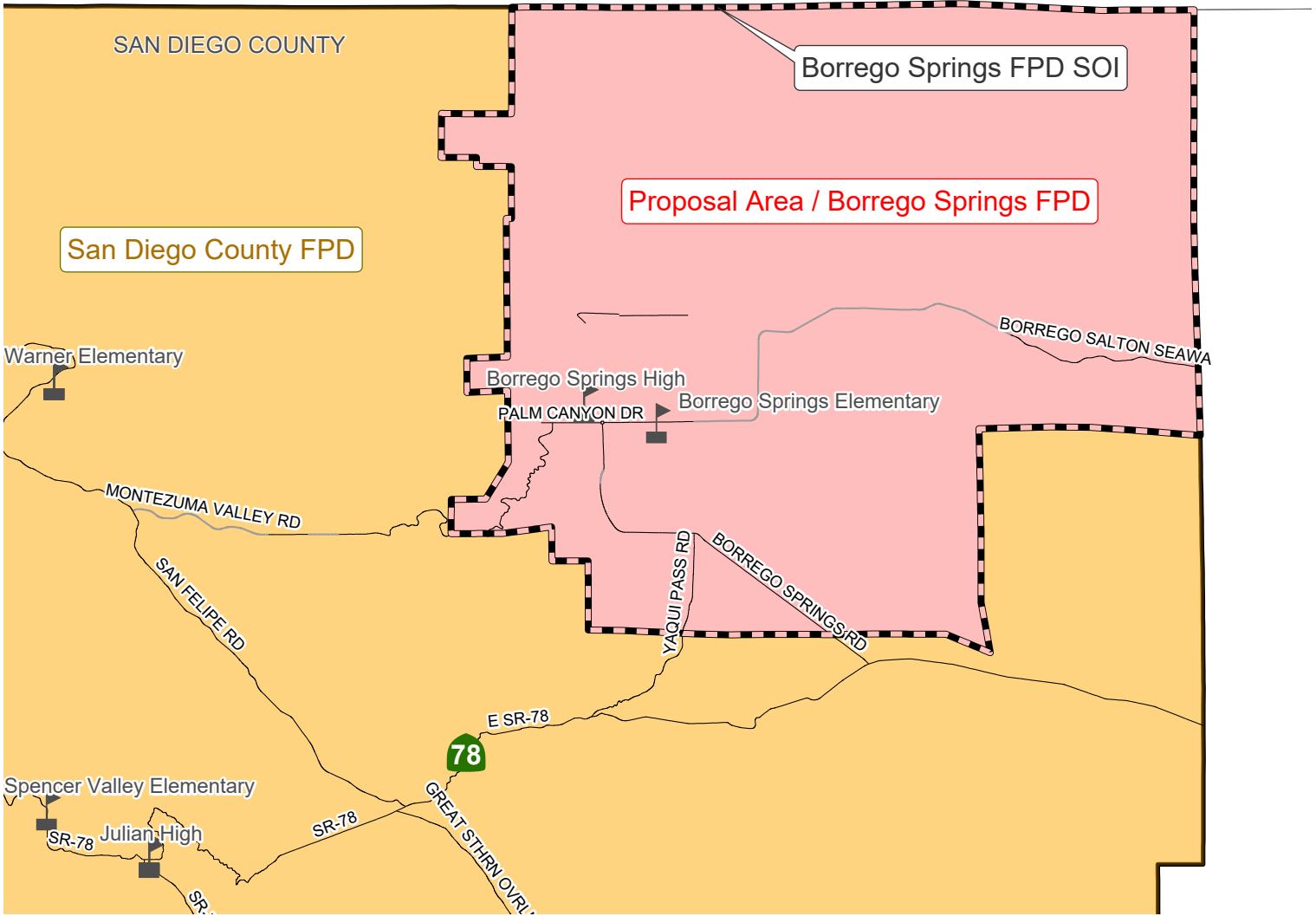
