## NOTICE OF PUBLIC HEARING

Notice is given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, May 1, 2023 starting at 8:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

### - PROPOSED “CUMMING RANCH REORGANIZATION” - RAMONA MUNICIPAL WATER DISTRICT LATENT POWERS EXPANSION

During the public hearing, LAFCO will consider the above-cited reorganization proposal filed by resolution of the Ramona Municipal Water District (MWD). The proposed reorganization involves the expansion of Ramona MWD’s activated wastewater service area to include approximately 683 acres and involves multiple parcels presently undeveloped located on Highland Valley Road. The purpose of the proposed reorganization is to make public wastewater services available to facilitate the planned future development of 125 single family residences as part of the Cumming Ranch subdivision. The proposal also necessitates a conforming sphere of influence amendment specific to Ramona MWD’s activated wastewater service area to include the affected territory.

The public is encouraged to review these materials and provide comments.
