NOTICE OF PUBLIC HEARING

Notice is hereby given the San Diego County Local Agency Formation Commission (“LAFCO”) - a political subdivision of the State of California with regulatory and planning duties - will hold a public meeting on **Monday, June 5, 2023 starting at 8:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Board Chambers, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “FALLBROOK PUD & RAINBOW MWD WHOLESALER REORGANIZATIONS” -
CONCURRENT ANNEXATIONS TO EASTERN MUNICIPAL WATER DISTRICT
AND DETACHMENTS FROM SAN DIEGO COUNTY WATER AUTHORITY
WITH RELATED ACTIONS**

At the June 5, 2023 meeting, San Diego LAFCO will consider two separate reorganization proposals filed by Fallbrook Public Utility District and Rainbow Municipal Water District that have been administratively combined for hearing purposes by the Executive Officer. The proposals seek LAFCO approvals to transfer wholesale water service responsibilities within the applicants’ jurisdictional boundaries from the San Diego County Water Authority to Eastern MWD. The purpose of the proposals is to achieve cost-savings to the applicants and their retail ratepayers based on the difference in charges between the two wholesalers.
