NOTICE OF PUBLIC HEARING

Notice is given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, November 6, 2023 starting at 8:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “AJX HOMES LLC-CARMICHAEL DRIVE REORGANIZATION” -
 ANNEXATION TO THE CITY OF LA MESA WITH CONCURRENT DETACHMENT FROM SAN MIGUEL FIRE
 PROTECTION DISTRICT AND RELATED SPHERE OF INFLUENCE ACTIONS**

During the public hearing, LAFCO will consider the above-cited reorganization proposal filed by landowner petition. The proposed reorganization involves the annexation of one unincorporated parcel located in the community of Valle de Oro to the City of La Mesa. The purpose of the proposed reorganization is to make public wastewater services available to remedy a failed septic system. The proposal also necessitates a conforming sphere of influence amendment to the City of La Mesa to include the affected territory as well as a sphere of influence amendment to the San Miguel Fire Protection District to exclude the affected territory and necessitates consideration as part of a noticed hearing.

Documents regarding the reorganization proposal – including a map of the proposed affected territory – are available for viewing online at www.sdlafco.org now and will include posting of the staff report and recommendation no later than 96-hours before the scheduled hearing. The public is encouraged to review these materials and provide comments.
