NOTICE OF PUBLIC HEARING

Notice is given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, May 6, 2024 starting at 8:00 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Board Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “SKY RANCH CHANGE OF ORGANIZATION” -
 PROPOSED DETACHMENT FROM HELIX WATER DISTRICT AND CONFORMING SPHERE AMENDMENT**

During the public hearing, LAFCO will consider the above-cited change of organization proposal filed by resolution of the Padre Dam Municipal Water District. The proposed change of organization involves the detachment of incorporated territory – spanning approximately 26.5 acres – located within the City of Santee from the Helix Water District. The purpose of the proposed change of organization is to eliminate an existing overlap between two public water service providers and align the respective service areas consistent with existing infrastructure. The proposal also requires a concurrent sphere of influence amendment to Helix Water District to exclude the entire affected territory and necessitates consideration as part of a noticed hearing.

Documents regarding the change of organization proposal – including a map of the proposed affected territory – are available for viewing online at www.sdlafco.org now and will include posting of the staff report and recommendation no later than 96-hours before the scheduled hearing. The public is encouraged to review these materials and provide comments. Written comments provided before **Friday, May 3, 2024** will be incorporated into the staff report presented to the Commission and should be directed to Michaela Peters at michaela.peters@sdcounty.ca.gov. All other comments should be provided during the hearing either in person or by following the remote instructions provided on the accompanying agenda.
