**NOTICE OF PUBLIC HEARING**

Notice is given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, March 3, 2025 starting at 8:15 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Board Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “HUANG – MT. WHITNEY ROAD CHANGE OF ORGANIZATION” -  
 PROPOSED EXPANSION OF RINCON DEL DIABLO MWD’S ACTIVATED WASTEWATER  
 SERVICE AREA & RELATED SPHERE ACTION**

During the public hearing, LAFCO will consider the above-cited change of organization proposal filed by landowner petition. The proposed change of organization involves the annexation of approximately 0.91 acres of unincorporated territory in the community of San Dieguito to Rincon del Diablo Municipal Water District’s activated wastewater service area. The affected territory presently lies entirely within Rincon MWD’s jurisdictional boundary and primary sphere of influence but outside the District’s activated wastewater service area and associated secondary sphere of influence. The purpose of the proposed change of organization is to establish public wastewater service and in doing so accommodate the planned development of a single-family residence. The proposal also requires a concurrent sphere of influence amendment to the Rincon del Diablo Municipal Water District’s activated wastewater service area and necessitates consideration as part of a noticed hearing.
