NOTICE OF PUBLIC HEARING

Notice is given the San Diego County Local Agency Formation Commission (“LAFCO”) will hold a public meeting on **Monday, May 5, 2025 starting at 8:15 a.m.** at the County of San Diego Administration Center at 1600 Pacific Highway, Board Room 302, San Diego, California. At the public meeting, LAFCO will consider the following public hearing matter:

**- PROPOSED “CAVANAUGH – LINDA VISTA DRIVE CHANGE OF ORGANIZATION” -
 PROPOSED ANNEXATION TO THE VALLECITOS WATER DISTRICT & RELATED SPHERE ACTION**

During the public hearing, LAFCO will consider the above-cited change of organization proposal filed by landowner petition. The proposed change of organization involves the annexation of approximately one-acre of incorporated territory located in the City of San Marcos to the Vallecitos Water District. The affected territory lies outside the sphere of influence for Vallecitos Water District and includes one vacant undeveloped parcel. The purpose of the proposed change of organization is to establish public wastewater services to accommodate the planned development of one single-family residence and detached garage. The proposal also requires a concurrent sphere of influence amendment to the Vallecitos Water District and necessitates consideration as part of the noticed hearing.

The public is encouraged to review these materials and provide comments. All other comments should be provided during the hearing either in-person or by following the remote instructions provided on the accompanying agenda.
