SUBJECT: **Appointment of Regular Public Member and Other Possible Actions**

SUMMARY

The San Diego County Local Agency Formation Commission (LAFCO) will revisit consideration to fill the vacant regular public member position. The item has been placed on the agenda at the request of Vice Chair Willis and follows unsuccessful motions to fill the position at the last meeting held on June 2nd. Vice Chair Willis has requested the item be revisited for the specific purpose of reconsidering the failed motion to appoint Brigitte Browning to fill the regular seat and fill the resulting vacancy in the alternate seat with Eileen Delany. A successful appointment to any public member seat on LAFCO requires meeting two thresholds: a majority vote among the four membership categories (County of San Diego, City of San Diego, cities, and special districts) and at least one affirmative vote from each category.

BACKGROUND

Membership Composition

San Diego LAFCO’s membership structure is prescribed by State law and consists of 13 positions. These positions are divided into five distinct categories: County of San Diego, cities less the City of San Diego, City of San Diego, independent special districts, and the general public. Each position includes both regular and alternate members. Only the public member category - including both the regular and alternate positions - is appointed directly by LAFCO.

- (b) If needed, make an appointment of an alternate public member by majority vote along with at least one affirmative vote from each membership category.

Alternative Two:

Continue the item to a future meeting.

Alternative Three:

Take no action. (Under this alternative, alternate Brigette Browning would continue to vote in lieu of a regular appointee.)

SUBJECT: Appointment of a Public Member and Other Possible Actions

SUMMARY

The San Diego County Local Agency Formation Commission (LAFCO) will consider candidate recommendations from its Executive Committee to fill a vacant Regular Public Member seat with a term extending through April 2029. The Committee — comprised of Chair Stephen Whitburn, Vice Chair Barry Willis, and Immediate Past Chair Jim Desmond — interviewed several finalists selected from a pool of 20 eligible applicants. Following deliberation, the Committee voted unanimously to nominate and advance three candidates for consideration by the full Commission. While the Commission retains discretion in determining its approach for considering candidates, staff has advised all three candidates to be prepared to deliver a brief verbal summary of their interests and qualifications as well as to respond to any specific questions. Appointment to the Regular Public Member seat requires a majority vote from the other four membership categories (County of San Diego, City of San Diego, cities, and special districts); it also requires at least one affirmative vote from each category. Additionally, and as a contingency allowed under policy, the item notice allows for the Commission to make an appointment to the Alternate Public Member position if it becomes vacated as a result of the Regular Member appointment.

BACKGROUND

Membership Composition

San Diego LAFCO's membership structure is prescribed by State law and consists of 13 appointed Commissioners. These Commissioners are divided into five distinct categories: County of San Diego, cities less the City of San Diego, City of San Diego, independent special districts, and the general public. Each category includes both regular and alternate members. Only the public member category - including both the regular and alternate positions - is appointed directly by LAFCO. Appointments to the other four categories are made externally consistent with statutory provisions.

Administrative Policy 109 (A-109) | Public Member Appointments: Objectives and Procedures

San Diego LAFCO adopted a formal policy guiding public member appointments in February 2025. The policy establishes both procedural steps and selection criteria along with articulating broader goals and objectives for public representation. Among policy priorities are demonstrated experience in local government or community advocacy and prioritizing diversity, including geographic representation. To this end, the policy specifies that one public member must reside in an incorporated area and the other in an unincorporated area, unless this requirement is formally waived. Candidate eligibility is defined by State law and requires applicants to be residents of San Diego County who are not officers or employees of the County, any city, or any independent special district.

With respect to the selection process, the policy delegates authority to the Executive Committee to oversee the noticing, recruitment, screening, and interviewing of candidates. However, the policy requires the Committee - by majority vote - to advance no fewer than two candidates for full Commission consideration at a publicly noticed hearing. In addition, the policy provides all Commissioners with the opportunity to review the list of eligible applicants and submit individual nominations for concurrent consideration by the Commission. In accordance with State law, any appointment to the public member position must receive a majority vote from the other four membership categories (County of San Diego, City of San Diego, other cities, and special districts), including at least one affirmative vote from each category. A copy of the policy is provided as Attachment One.

DISCUSSION

This item is for San Diego LAFCO to consider three candidates recommended by the Executive Committee for possible appointment to the Regular Public Member seat involving an active term extending through April 2029. The three candidates are Brigitte Browning, Greg Cox, and Eileen Delany.¹ While the Commission retains discretion in considering candidates, staff has advised all three candidates to be prepared to deliver a brief verbal summary of their interests and qualifications as well as to respond to any specific questions. If necessary, this item also allows the Commission to draw from the candidate pool to make an appointment to the Alternate Public Member seat should it become available.

¹ No other candidates have been nominated as allowed under policy by individual Commissioners.

Additional details regarding the recruitment and screening process preceding today's noticed hearing are provided in Appendix A.

ALTERNATIVES FOR ACTION

The following alternative actions are available to San Diego LAFCO:

Alternative One (recommended):

- (a) Make an appointment of a public member by majority vote along with at least one affirmative vote from each membership category.
- (b) If needed, waive A-109 provision that otherwise requires one public member reside in the unincorporated area and the other resides in the incorporated area.
- (c) If needed, make an appointment of an alternate public member by majority vote along with at least one affirmative vote from each membership category.

Alternative Two (recommended):

Continue the item to the next regular meeting.

PROCEDURES FOR CONSIDERATION

This item has been placed on San Diego LAFCO's agenda for action as part of a noticed hearing. The following procedures are recommended in the consideration of this item:

- 1) Disclose any material ex-parte communications.
- 2) Invite each candidate to present.

Appendix A

Executive Committee Procedures + Deliberations

Recruitment | Staff Outreach & Candidate Pool

An open recruitment process was conducted in accordance with the Commission’s recently adopted Public Member Appointment Policy (Policy A-109). Recruitment efforts included posting announcements online and publishing a notice of vacancy in the San Diego Union-Tribune on March 12, 2025, inviting interested San Diego County residents to apply. A total of 20 eligible applications were received during the 30-day filing period, including one from current Alternate Public Member Brigitte Browning. Two additional applicants were deemed ineligible due to employment or office with a local agency under LAFCO jurisdiction.

Recruitment | Executive Committee Deliberations

The Executive Committee convened on April 17 to review all eligible applications and, by consensus, invited four candidates to participate in interviews. These individuals were: Brigitte Browning (current Alternate Commissioner), Greg Cox (former Commissioner and County Supervisor), Ed Sprague (former Commissioner and retired Fire Chief), and Eileen Delaney (Chair of the Fallbrook Community Planning Group). Interviews were conducted at a noticed meeting held on May 14. Following deliberation, the Committee nominated the following three candidates for consideration by the full Commission (alphabetical order):

1. Brigitte Browning
2. Greg Cox
3. Eileen Delaney

A full list of applicants was provided to Commissioners along with the Executive Committee’s nominations and notice of the opportunity for individual Commissioners to submit additional nominations. The deadline to submit individual nominations was May 26, 2025. No individual nominations were received by this deadline.

ADMINISTRATIVE POLICY A-109

Subject

PUBLIC MEMBERS APPOINTMENTS

Purpose

Provide rules and procedures to guide the appointment of public members to the Commission in an inclusive, clear, and fair process.

Background

State law specifies the composition of the Commission shall include one member representing the general public with the option to also designate an alternate (Government Code Section 56325).

Policy

It is the policy of the Commission:

A. Goals and Priorities:

- 1) The Commission shall appoint both regular and alternate public members. One member shall reside in the unincorporated area and the other member shall reside in the incorporated area.
- 2) The Commission shall prioritize experience in local government and/or community advocacy in considering public member appointments.
- 3) The Commission shall consider geographic and other lived diversities in appointing public members to help advance balanced decision-making.
- 4) The Commission tasks the Executive Officer to exercise their best judgement in ensuring robust and inclusive outreach is performed anytime an open recruitment is conducted under this policy.

B. Appointment Eligibility:

- 1) As required under State law, public member appointees shall be residents of San Diego County. Appointees shall not be current officers

or employees of the County of San Diego or local cities and special districts.

- 2) Elected officials serving on any of the County of San Diego advisory planning groups retain appointment eligibility to concurrently serve as public members on LAFCO.
- 3) Appointees may concurrently hold other appointed positions with the County of San Diego or local cities and special districts (e.g., art commissions, measure oversight committees, advisory planning groups).

C. Appointment Terms:

- 1) All public member terms are four years and begin on the first Monday of May in the year appointed. Any mid-term vacancies shall be filled with appointees assuming the unexpired terms.
- 2) There are no term limits for public members.

D. Full Term Appointments

- 1) No less than 90 days in advance, the Executive Officer shall provide notice to the Commission on the agenda advising of any pending term expirations involving the public member positions – regular or alternate.
- 2) At the time of receiving notice of a pending term expiration involving a public member position, the Commission shall provide direction to LAFCO staff to proceed either with an open recruitment, an expedited reappointment, or when applicable, conduct a limited recruitment wherein the Commission draws from a pool of candidates from a prior recruitment, provided it has occurred within the past six (6) months to expedite the filling of the vacancy.
- 3) The following appointment procedures are specific to Commission direction to proceed with an open recruitment process.
 - a) LAFCO staff shall perform outreach on the open recruitment and prepare an advertisement for local publication (print and media) and posting inviting eligible applicants to submit a letter of interest.

- b) The application period shall extend to no less than 30 days and may be extended as needed until two or more letters of interests are submitted by eligible applicants.
- c) All submitted letters of interests received by the close of the application period shall be immediately transmitted to the full Commission.
- d) The Executive Committee (Chair, Vice Chair, and Immediate Past Chair) will screen all applicants, select applicants to interview, and conduct interviews of selected applicants at a noticed special meeting.
- e) The Executive Committee will nominate two or more applicants for consideration by the full Commission at a future meeting for which LAFCO staff can provide legally required notice. The list of the nominations from the Executive Committee shall be provided to all Commissioners no less than 10 days prior to the noticed meeting.
- f) Any Commissioner may also nominate an applicant for consideration by the full Commission at the noticed meeting no later than five (5) days prior to the noticed meeting. Notice shall be given to the Executive Officer.
- g) At a noticed meeting, with the opportunity to continue, the full Commission will consider all nominated applicants, and at the discretion of the Chair this may include inviting presentations and/or conducting interviews.
- h) A successful appointment shall achieve no less than four (4) affirmative votes from voting Commissioners and include therein at least one affirmative vote from each of the following four membership categories:
 - County of San Diego
 - Cities Less San Diego
 - Special Districts
 - City of San Diego
- i) In the event no candidate receives both a majority vote and an affirmative vote from each of the four membership categories, the Commission shall conduct a run-off vote of two candidates receiving the most votes. In the event that neither candidate receives a majority vote and an affirmative vote from all four membership categories, the Chair shall either continue consideration to a future meeting or provide direction to restart the recruitment process in the manner prescribed under this policy.

- 4) The following procedures are specific to Commission direction to proceed with an expedited reappointment of the incumbent.
 - a) The Commission will take up the expedited reappointment at the next regular meeting for which LAFCO staff can provide legally required notice.
 - b) A successful reappointment is subject to the same voting thresholds identified in the preceding subsection.
- 5) The following procedures are specific to Commission direction to proceed with a limited recruitment wherein the Commission draws from a pool of candidates from a prior recruitment, provided that the recruitment occurred within the past six (6) months.
 - a) LAFCO staff shall conduct outreach to candidates who were not selected during the prior recruitment but remain eligible for reconsideration at the discretion of the Commission.
 - b) The recruitment shall follow the same procedures as outlined in Section D (Full Term Appointments), subsection 3, paragraphs d through i.

E. Mid Term Vacancy Appointments

- 1) If the regular public member position becomes vacant prior to the term expiration, the Executive Officer shall provide notice to the Commission on the agenda at the next regular meeting. The Commission may proceed thereafter in providing direction to LAFCO staff of its intentions to either appoint the alternate, proceed with an open recruitment, or when applicable, conduct a limited recruitment wherein the Commission draws from a pool of candidates from a prior recruitment, provided it has occurred within the past six (6) months to expedite the filling of the vacancy.
 - a) Any direction to proceed with appointing the alternate to fill a mid-term vacancy shall be considered for action at the next regular meeting in which LAFCO staff can provide legal notice.

- b) Any direction to proceed with an open recruitment to fill a mid-term vacancy shall follow the same procedures for full term appointments.
- c) Any direction to proceed with a limited recruitment to fill a mid-term vacancy shall follow the same procedures outlined for full term appointments.

The Executive Committee will interview selected candidates and invite no less than two finalist candidates to be interviewed by the full Commission at a noticed hearing with a formal selection to follow.



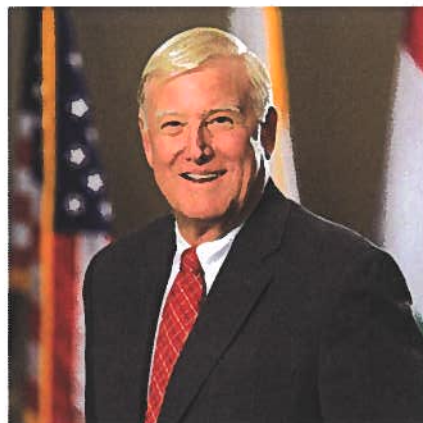
After more than 45 years in public service, Greg Cox's last day as an elected official was January 4, 2021.
