PROPOSED FINAL WORKPLAN AND BUDGET FOR 2026-2027
30-DAY REVIEW AND COMMENT PERIOD + NOTICE OF PUBLIC HEARING

San Diego County Local Agency Formation Commission (LAFCO) is a political subdivision of the State of California with regulatory and planning responsibilities to facilitate timely formation and development of cities and special districts with respect to their physical boundaries and authorized service areas. This includes approving local agency boundary changes, authorizing out-of-agency contracts, setting and updating spheres of influence, and regularly preparing studies to assess the availability, need, and performance of municipal services and related governance.

San Diego County LAFCO will hold a public meeting on Monday, May 4, 2026 starting at 8:15 a.m. at the County of San Diego Administration Center at 1600 Pacific Highway, Room 302, San Diego, California. At the public meeting, LAFCO will consider the above-listed item - proposed final workplan and budget for 2026-2027 - and in doing so prioritize activities and related resources for the upcoming fiscal year.

Draft versions of both the proposed workplan and budget were tentatively approved by LAFCO at its March 2nd meeting and are available for review online by visiting the LAFCO homepage at www.sdlafco.org. Comments on both documents are welcome. Public comments received by Tuesday, April 14th will be incorporated into the agenda item presented to the Commission for final actions at the May 4th hearing.
